The Hawaii State Coalition Against Domestic Violence (HSCADV) is a private, not-for-profit organization formed in 1980. HSCADV is a coalition comprised of domestic violence programs throughout the state of Hawaii which respond to the problem of intimate partner abuse. These programs include shelters, psycho-educational counseling programs that provide service to victims and batterers, and legal service providers. It is the mission of HSCADV to ensure the safety and protection of battered women in intimate relationships by coordinating domestic violence prevention and intervention services, providing training and education and technical assistance, affecting public policy, and establishing coordinated and consistent procedures and actions by the civil and criminal justice systems in Hawaii.

## Training Descriptions

### **Sexual Violence and DV: Child Victims**

This training will focus on the dynamics of child sexual abuse, as well as effects of sexual abuse on children, including Post-Traumatic Stress Disorder (PTSD) and reactive behaviors. Connections between sexual abuse and domestic violence will be discussed, as well as resources for supporting child victims.

The training will also include examples for (DV & spiritual) advocates to use in their work within faith and domestic violence issues.

## Domestic Violence 101: A 25 Hour Training

### **Domestic Violence 101: A 25 Hour Training**

This training is a four-day experience including but not limited to: the history of feminism and the Battered Women's Movement, privilege and oppression in society, gender roles and gendered socialization, working with victims, understanding batterers, the legal system, effects of domestic violence on children, safety planning, immigrant populations, and resources and referrals.

HSCADV recommends that all staff that have any level of contact with victims of domestic violence complete this training for the protection of victims' confidentiality.

Hawaii Revised Statute 06262-0001-505.5 provides client/counselor privilege to individuals who:

- 1) work for a domestic violence agency,
- 2) are supervised by a domestic violence supervisor, and
- 3) have completed a 25 hour domestic violence training.

Participants are required to maintain their documentation of completion as HSCADV does not keep records on this. All participants who complete this four-day training will receive a comprehensive resource manual that includes information on the above topics and other related information and a certificate of completion.

## Training Descriptions

### **Immigrant Victims of Domestic Violence**

This training will focus on immigrant victims of domestic violence and their children. This training will provide information on relief and resources available to immigrant victims and their children in Hawai'i. Participants will learn about the services available to improve or enhance their work with immigrant victims.

### **Understanding the LGBT Community and DV**

This training will focus on the Lesbian, Gay, Bisexual, and Transgender community, nationally as well as in Hawai'i. This training will focus on the realities of the LGBT community in Hawai'i and throughout the country. This training will address issues of homophobia, "outing," and internalized oppression, as well as the importance of sensitivity and inclusivity in providing domestic violence services to the LGBT population.

This training will explore common paradigms on working with “challenging” personalities and understand the underlying reasons for the behaviors. Through this training service providers will be able to examine the disparity between expectations and reality.

### Working with Women Coping with Substance Abuse, Mental Illness & Domestic Violence

This discussion is intended to educate and dispel the myths surrounding these difficult and highly charged challenges for both victims and service providers

### Stalking: An Overlooked Crime

Surveys show that there is compelling evidence of the link between stalking and other forms of physical and emotional violence in intimate partner relationships. This training will define stalking and teach about stalking laws and how to assist victims who are being stalked.
