

### 2020 HSCADV CONFERENCE

#### BUILDING ON THE STRENGTHS OF OUR COMMUNITY



Thank you to all who participated and helped make HSCADV's first virtual conference a success. There were more than 170 attendees from all the neighbor islands and the U.S. continent. Due to the coronavirus pandemic, we moved the annual conference to a virtual format on August 3-6, 2020. Each workshop averaged between 90-110 attendees and included a mix of victim advocates, mental health professionals, law enforcement, social service providers, and students.

This year's conference theme, "Building on the Strengths of Our Community" was intended to engage our community a conversation about the primary prevention of domestic violence, a call on us to look within the strengths of our community for the solutions we seek to end domestic violence.

We were honored to have **Arlene Vassell**, Vice President of Programs, Prevention, & Social Change at the National Resource Center on Domestic Violence lead our keynote with **Anita Momilani Awo**, Social Services Team Lead at Lili'uokalani Trust.


#### BUILDING ON THE STRENGTHS OF OUR COMMUNITY

#### DOMESTIC VIOLENCE AWARENESS MONTH

### HOW DID THE COALITION RAISE DOMESTIC VIOLENCE AWARENESS?

Although social distancing requirements this year reduced the number of events, we were proud to uplift the events of our member programs this month. From Facebook Live sessions led by the Legal Aid Society of Hawai'i and community town halls by the Domestic Violence Action Center to the Drive-Thru organized by Women Helping Women, HSCADV members found new and innovative ways to raise the awareness of domestic violence while also honoring survivors and their staff.

HSCADV's theme for the month, and beyond is **No Room for Violence** (#NR4V). With this message, we're inviting our community-at-large to join the movement against gender-based violence and to take a stand against all forms of violence in our relationships, homes, and communities across the state. The COVID-19 pandemic has demonstrated that there is no room in our homes, communities or hearts for violence.



HSCADV'S most anticipated project was the **Bursting Bubbles** collaboration with Playbuilders of Hawai'i Theater Company. This four-episode project was created by and for survivors and is accompanied by panel discussions featuring local domestic violence experts. The first video, Jenny's Story, aired on 'Olelo and highlighted Jenny Delos Santos's journey to safety and healing. The panel included Cristina Arias, Vice President of Survivor Advocacy Services at the Domestic Violence Action Center, Dr. Steven Dick, Therapist of the YWCA of Kaua'i, and Chiyo Churchill, Program Director at Catholic Charities Hawai'i Counseling Center. ## PROGRAM UPDATES

#### \*STAR ADVOCATE - JASON ESTRELLA\*

The Island of Hawai'i YMCA Family Visitation Center Director, Jason Estrella, is this month's Star Advocate. He is being recognized for his initiative to take safeguards and support youth participants. Despite the temporary stoppage of some programs and minimized staff caused by COVID-19, Jason volunteered his own time during the evenings and weekends and conducted supervised video visits. He also managed to juggle that with volunteering for the Hawai'i Jiu Jitsu Foundation by educating staff about mandatory reporting policies of suspected abuse and safe practices to protect vouth athletes from sexual and other forms of abuse. A true asset to the YMCA and the East Hawai'i community, Jason is commended for his hard work and dedication.

#### **WOMEN HELPING WOMEN**

WHW was recently awarded a Mary Kay Grant and Sanoe Ka'aihue was nominated for the Maui Nonprofit Directors Association's Nonprofit Executive Director of the Year Award. They hosted a "Go Purple Drive-Thru" Resource Fair for DVAM and collaborated with the Akaku radio station to air PSAs in October.

#### **NEIGHBORHOOD PLACE OF KONA**

NPK has been actively collaborating with Kosraean communities and promoting rental and food assistance while also operating prevention programs to help people cope with COVID-19 related stress. They also recently partnered with Ke Ala Ho'aka (KAHA) to provide training on adverse childhood experiences and cultural trauma.

#### **CFS WEST HAWAI'I**

CFS West Hawai'i is renovating their shelter and recently hired two new staff members (Tiana Aja & Courtney Boykin) who are in the Alternatives to Violence program to help process TROs.

#### ISLAND OF HAWAI'I YMCA

Through public support and recent donations, the visitation program has been doing consistent supervised video conferencing between parents and children. The YMCA Men's International membership also donated six new iPads for this program.

#### CFS O'AHU

CFS reports more male survivors calling to the CFS crisis line. In response, they started a new support group for male survivors.

Participants attend sessions through Zoom and so far there has been increased interest in the group and success.

CFS is also working with the Partners I n Care Coordinated Entry System (CES) to develop a comparable database to the HMIS to address the housing needs of clients. This system serves as a conduit for several community organizations to collaborate and find permanent housing for the homeless. The organization is also opening a Family Center in downtown Chinatown on O'ahu.

#### **PAU VIOLENCE**

PAU Violence recently celebrated a successful DVAM where they partnered with various groups within the UH system for virtual events and continued training for faculty, staff, and students. They also moved their bystander intervention training to a virtual format which includes sessions on dating violence and sexual assault.

#### **LEGAL AID SOCIETY OF HAWAI'I**


Legal Aid has been receiving many unemployment and housing/eviction cases. To help ease confusion about available resources, Legal Aid has been regularly releasing flyers and information about programs on their website in several languages.

It also includes language access in fifteen languages. The website was also updated for visitors to find the resources they need faster by filtering them by issue and/or region.

#### COVID-19

Coalition staff continue to work from home and support survivors and their families seeking help and referrals and member program staff. In response to the needs of member programs, HSCADV was able to successfully advocate for \$1.4 million in CARES Act funding and provide the following webinars and collaborations:

We continue to work with the State of Hawai'i Judiciary and the Center for Court Innovation (CCI) on the revision of the state's Batterer Intervention Program Standards. CCI successfully executed several surveys and focus groups of service providers and community programs which culminated in a three-part training series: Enhancing Holistic Abusive Partner Intervention Responses in Hawai'i.
